CALL TO ORDER

Tina Gill called to order the Board meeting of the Arkansas Cancer Coalition at 11:20 am on September 4, 2018 at 10825 Financial Centre Parkway, Little Rock.

Executive Director Report

Trena Mitchell

Highlights

- Kirsty DeHan has been promoted to Communications Specialist
- The Executive Assistant position is now open, ACC hopes to fill the position by October 1.
- Last year ACC had found an office where all of the staff could be located together, but someone else signed a contract before us. We have now built out a space on the 4th floor where all staff can share office space and Trena is no longer on a separate floor. Board members are welcome to come visit the new office.
- ACC had a site visit from CDC Aug 28-30. Georgina Castro, Annette Gardener and Olivia Marr came from Atlanta and met with ACC and ADH-CCC staff.
 - The visit consisted of how the ACP3 was revised, evaluation of CCC, Cancer Leadership Team efforts, and the CCC workplan. We plan on working with BreastCare Outreach Coordinator, Gloria Bastidas, to open up to the Hispanic population and provide more outreach opportunities.
 - Annette Gardener requested a copy of ACC Bylaws, Grand Rounds presentation, Workplan (including evaluation tools), and success stories. Two of ACC's success stories have been published by CDC.
- ACC is not sure if CDC will visit annually or if it will be every 5 years. We have not had a site
 visit since Trena has been ED. Annette was very pleased with her visit, she came here
 thinking she had her work cut out for her like a lot of southern states, but she was very
 pleased with our success! Treg Long gave her a lot of background to ACC and its history.

- All contracts are signed, 2 are secured and in place for a 1-year contract. TPCP will start October 1 and will be an 11-month grant, it is almost time to go through legislative review and then once approved we can expense from TPCP.
- Debbie Rushing is no longer with TPCP. The position has been filled by Joy Gray.
- The Tobacco and Disease Symposium is November 16, from 8am-5pm at the UAMS Spine
 Institute. Cost is \$50 for the full day. The agenda includes: motivational interviewing, coding,
 CO monitoring, and E-cigarettes. Trena will send an agenda to the board, it is geared toward
 Primary Care Physicians.
- The 20th Arkansas Cancer Summit is March 27-28, 2019. The first day is the Summit and the second day is the Arkansas Tobacco Control Conference hosted by the Arkansas Tobacco Control Coalition
- The Summit committee has met once, the next meeting is September 25 at 10am.
- Kirsty will add Dr. Tillman to the Summit Planning Committee
- Tina suggested adding vaping to the Summit, this could be part of day two which is more tobacco focused.
- Another suggestion was Dr. Bates educating physicians
- Dr. Makhoul suggested substance abuse: raise awareness of alcohol use, medical marijuana.
 Dr. Makhoul read an article about substance abuse and will send to the board.
- ACC will host the SE CRC Consortium in 2019
- ACS has committed to \$5,000 for the SE CRC Consortium, the health department is working out how much they can contribute.
- Around \$50,000 is needed to host the SE CRC Consortium in Arkansas for 3 days. We will also be soliciting sponsors. The conference is expected to be in June.
- Dr. Makhoul said he spoke with UAMS and RASCO is interested in combining the conference with the SE CRC Consortium
- Dr. Berger would be the person to speak to about any questions regarding sponsorship and if the consortium has the same sponsors as RASCO
- RASCO, Summit, and the consortium should all work together and promote the next event at each event. ACC will attend the next RASCO meeting.
- Mosaic Temple Multicultural center could use for a reception for the SE CRC Consortium.

- -Work with ACS to push legislation with colorectal cancer.

Tina Gill asked: What percentage is Arkansas Screening Rate?

Trena: 7.8% increase

Michael Preston added: We just got our colorectal program registered on the national cancers to research testing intervention program, now it's evidence-based space intervention and available on their website. Only 20 programs in the country and we are one of them.

Arkansas State Fair: October 11th - 21st

We were able to reach insured and under-insured.

Harding university is a big partner, Pharmacy students came to perform services.

 82 FIT tests
- 379 surveys 33 counties reached 4 red counties reached (Jefferson, Phillips, Poinsett, and Logan)
- Myca: we may have reached more red counties there is a chance that number is a little bit higher

Olivia Wyatt added: Why not go to all the county fairs to reach more of the red counties.

Trena: We wanted to do that last year, we just did not have the travel budget. This fair is the largest fair, and people travel to come to the AR State Fair. If we can increase our travel budget, this can happen.

Alicia Storey added: St Bernard has a booth at Craighead County Fair is right in the middle of the red counties around the 3rd week of September (Invited us to be a part).

During the May 7, 2019 ACC Board meeting, an Executive Session was called and staff, with the exception of the ED, Trena Mitchell, were asked to step out of the room. Trena was asked to clarify the intent behind the proposed Performance Review and Bonus Structure for staff compensation (see below as well as attached) and was then asked to step out.

A lively discussion ensued and ultimately the Proposal was approved with the following caveats:

- a. This approval is for a one-year only trial to be revisited by the Board each year
- b. The Proposal will be implemented only as funds are available

The Performance Review Premium should take place in FY 2020, as determined appropriate by the ED, and the Annual Career Service Recognition Payments may occur upon the staff member's next anniversary date.

1. Performance Review Premium

The Arkansas Cancer Coalition has established a maximum percentage for Annual Performance Review Premium and Career Services Recognition that could occur in each of the three new categories of performance measures. It also set a cap for the Coalition on how much total money the Coalition may spend on Annual Performance Review Premium and Career Services Recognition. The maximum money the Coalition may spend for bonuses may not exceed 2.8% of total annual revenue. The 2.8% cap allows the Arkansas Cancer Coalition to spend \$31,780 for fiscal year 2020.

Bonus formulas will be based on current job descriptions that depict levels of responsibility and level of performance.

This results in the following percentages for ACC employees:

- Role Model 3%
- Highly Effective 2%
- Solid performer 1%
- Needs Development 0%

2. Annual Career Service Recognition Payments

An employee who meets eligibility requirements established by ACC Personnel shall become eligible for annual career service recognition payments on the anniversary date of the completion of such service according to the following schedule:

ACC SERVICE ANNUAL PAYMENT

- 3 to 5 years \$200
- 5 to 7 years \$400
- 7 to 10 years \$600
- 10 and above \$1000

This structure was adapted from the Department of Finance and Administration for Arkansas state employees. Amounts and percentages have been lowered to reflect the fact we are a non- profit organization.
