Tobacco Treatment Specialist Training (TTS)

The goal is for healthcare professionals to learn how to treat tobacco dependence by effectively delivering tobacco cessation treatment in both a clinical and/or community setting.

- Training provided in partnership with the University of Texas MD Cancer Center
- FREE 5 day training scheduled for April 19 23, 2021, 8am 5pm daily
- ACC's program goal is to train a minimum of 40 healthcare professionals
- Upon completion of the course and passing of exam, participants will be credentialed as Tobacco Treatment Specialists
- CE Credits are available in certain disciplines

Brief Tobacco Intervention Training for Healthcare Providers (BTI)

BTI training will instruct participants with developing quit plans for tobacco users, prescribing medications and referring patients for lung cancer screenings.

- Fall round of training was successfully completed November 4-6, 2020
- Our presenters were Julie Kissack, PharmD Pharmacotherapy, Patricia Franklin, APRN, TTS – Low Dose CT Screening and Sandra Brown, DNP – Motivational Interviewing
- 41 Total Participants 23 completed 3 days of training, 34 completed 2 days of training and 34 completed 1 day of training
- Over 23 participants earned CE credits
- Spring round of training is scheduled for February 2-4, 2021

FY21 Challenges

This budget is \$300,000 and this year is the first year we have a surplus of about \$40,000 left on this grant. ACC staff made every attempt to spend down the money, however our workplan changed mid fiscal year. TPCP made changes to the workplan and previously approved activities from the legislative review were taken off from workplan.
